TN SENATE - DISTRICT 28 JOEY HENSLEY



1. Why are you running for this position?

I have had the honor and privilege to serve in this position for the last 12 years. I have worked hard to represent the citizens of this district and will continue to be a voice for the people that have issues with state government. I am conservative and I firmly believe in the 2nd amendment and protecting the unborn.

2. What specific experience and qualifications do you have that make you the ideal candidate for this position?

I served 12 years on the Lewis County School Board, 3 years as chairman, and on the County Commission before being elected to the House of Representatives where I served for 10 years. I serve as chairman of the Revenue Sub-Committee on the Finance Committee in the Senate, and I serve on the Health Committee and on the Education Committee. I have the experience and qualifications to represent the people of this district and feel like I am the best candidate for this position.

3. What do you see as the top challenges for Maury County and how do you plan to contribute to addressing those?

Top challenges for Maury County are growth, infrastructure, education, and water issues for the county and communities. I have already been involved in all these issues and will work with the county and city governments to deal with these issues as Maury County continues to grow.

4. What do you see as the top opportunities for Maury County and how do you plan to utilize those to move our community forward?

The people of Maury County are its greatest asset. While growth creates problems, it also provides many opportunities for improvement in the lives of many in the County. Maury County has great educational opportunities with the location of Columbia State Community College in Columbia, and vocational schools close by in Pulaski and Hohenwald, as well as a UT Campus in Pulaski. These assets can provide the training that industries need to locate in Maury County. I am a proud alumni of Columbia State and I see the immense value that it provides as Maury County continues to grow. Maury County also has excellent county officials with a commission that is working hard to improve the County and I have been a partner with them to provide assistance from state government. Maury County also has communities in the county in Columbia, Spring Hill, and Mt. Pleasant that have officials that work with the county and state government for the betterment of the citizens of those communities which in turn benefits the county.

5. How do you plan to work collaboratively within the Tennessee General Assembly to ensure the decisions being made are in the best interest of Maury County as a whole?

I have already worked in the General Assembly to make sure decisions made at the state are in the best interest of Maury County. I have been a strong vocal advocate for the county and its citizens. I have sponsored legislation to improve education in Maury County and issues that the county commission needs at the state level. My office is always open to hear opinions and needs of the local government in Maury County as well as individual citizens.

6. With the growth facing Maury County, we are in great need of additional, and diversified, revenue streams to help fund the infrastructure to support the inevitable growth. Last session, legislation was passed to allow high growth County Governments to implement certain fees to assist with infrastructure related to growth. Do you feel this is an adequate solution? Why or why not?

The legislation that we passed last year was only one way to help the county to fund education. I co-sponsored and worked with the county through many meetings with groups that were involved with the legislation that passed in the senate. I personally worked with the members of the senate committee to get the legislation passed. It will allow high growth counties like Maury County and a few others to implement an adequate facilities tax on new development to help fund education specifically new schools in the future and to prevent increases in the property tax to other homeowners. The legislation is a good start, but is not all the answers to the growth that is occurring in Maury County and I will work with the Mayor and County Commission to find other solutions in the future.

7. What does thoughtful and sustainable growth in Maury County look like to you?

Sustainable growth is planned growth that is orderly and provides the needed infrastructure for the new development of residential and new businesses. Without thoughtful planning by the local government with help from the state, growth becomes a burden on local residents rather than a benefit. Also an issue that is happening is the ability of the cities and county to provide an adequate water supply for future growth. We are already making plans and working with the state and surrounding counties for a plan going forward to protect the beautiful scenic Duck River now and in the future and still provide adequate water for growth and continue the present need for water.

8. Quality education and a diverse workforce are vital for the successful growth of Maury County and its municipalities. If elected, how would you improve these areas?

Maury County already has an excellent school system both public and private schools that we need to support and help grow. Also, Columbia State Community College is a great resource for education and training for the jobs of the future. I serve on the Education Committee in the Senate and have worked to improve education all the time I have been in the Senate. Columbia State is building a new Health Science building that will improve their ability to provide expanded and diverse training that will be needed for future jobs. We need to provide the same opportunities for all of our citizens no matter their background or experience. We have the Hope Scholarship and the Tennessee Promise so that any student can afford Columbia State or a Vocational School free of charge. We need to encourage more students to take advantage of the opportunities and continue

to instill in high school students the need for continuing education after high school. I will continue to focus on improvements to education in Maury County and In the State of Tennessee.

9. How do you plan to communicate with, and be available to, your constituents?

I have always made myself available to anyone that might need me. I attend community events, Chamber of Commerce meetings and events and meet with constituents any time that they need me. I publish my office contact number, as well as my cell phone number in the newspaper and on social media. I have always and will continue to make myself available to anyone in the district that need help with state Government or just has an opinion or solution to problems that I need to know. I go to the grocery store at least once a week and go to the same places that everyone else goes, so I am in the community and always open to help anyone in the district.

10. What does a successful term look like to you?

A successful term is one that I can look back on and say that Maury County and its citizens are better off now than they were before and know that people in the district can be proud of the accomplishments. I will be a voice for the citizens of Maury County and when they say it was a good successful term, then I will consider it to be good. When I can say Maury County citizens have more opportunities than they had before, then it will be successful. We don't necessarily need more new laws, but sometimes we need to modify and change some of the laws and regulations in place now to make the lives of Maury County and Tennessee citizens better.

11. If elected, how do you plan to partner with the Maury County Chamber & Economic Alliance to make Maury County the best place to live and work?

I have already partnered with the Maury County Chamber of Commerce and Economic Alliance. I am an active member of the Chamber and attend most of their events, meetings and ribbon cuttings for new businesses. I make myself available to the businesses that locate in the county and let them know I am available if they need assistance. I am also a member of the Spring Hill\ Chamber and attend their events. I believe that it is important for all elected officials at every level to interact with businesses and individuals regularly. I represent the citizens of District 28 in the Senate and I have worked with the Chambers and will continue to work with them in the future. The Chambers work hard to attract new business to the county and I help when they need assistance from the state. I have a good working relationship with other state officials from Maury County as well as the County and City Officials. The Maury County Chamber and Economic Alliance is a great asset to Maury County and they have helped to attract many businesses to the County over the years. I am happy to work with them in the future as I have in the past to improve the lives of all Maury County Citizens.

TN SENATE - DISTRICT 28 JAMES DALLAS



1. Why are you running for this position?

I am running for Tennessee State Senate because, after more than a decade of one-party government, I believe our state is on the wrong path, and we need an alternative.

We are a growing state, but our economy is not growing sustainably or equitably. Our state is frequently among the lowest-ranking states in important quality-of-life metrics; for example, we rank 45th in air pollution, 37th for infant mortality, 44th in medical debt, 48th in violent crime, 42nd in commute time, and 41st in teacher salaries. Our state's leadership is in a "race to the bottom" with other Republican-led states and is increasingly focused on ideological hobbyhorses such as school vouchers instead of on improving the well-being of our people.

I believe you deserve a meaningful choice this November for the State Senate between more of the same and a hopeful, progressive vision for Tennessee.

2. What specific experience and qualifications do you have that make you the ideal candidate for this position?

I am a native Tennessean, and my parents and grandparents raised me to believe that we all can and should seek to make a positive impact in our community.

I have lived in Columbia for almost seven years, and I have put that belief into action by serving as a leader in the Maury County Democratic Party, a member of the Kiwanis Club, and a church volunteer.

I earned a Bachelor of Arts degree in Government from the University of Texas at Austin and a law degree from the University of Houston. I currently work as a database administrator at Vanderbilt University Medical Center. If elected, I believe I would be the only information technology professional in the State Senate. My unique experience in both law and technology will allow me to be a leader on increasingly important issues relating to government online services and online safety.

3. What do you see as the top challenges for Maury County and how do you plan to contribute to addressing those?

At a recent candidate forum in Spring Hill, Rep. Cepicky, Sen. Hensley, and I all agreed that growth is the most significant challenge facing our area. I think each of us would have a slightly different take on what "growth" means, however. For me, the biggest challenges related to growth are preserving our environment, affordability for homebuyers, and ensuring that we have adequate schools and roads to serve our residents.

There are two main issues concerning the preservation of our environment. First, we must ensure we have enough water to go around, and second, we must have a plan for waste disposal. These issues must be addressed in a way that does not harm the Duck River or other sensitive areas. We desperately need more regional planning in Middle Tennessee as we share those challenges with neighboring counties.

The most effective way to ensure affordable housing for Tennessee families is to encourage construction, particularly of smaller homes. Moreover, some tenants have recently seen large increases in their rents. While I generally do not favor government price control legislation (because it will discourage construction and hurt the rental market), I think in some cases it may be appropriate for the state or local governments to limit rental price increases, particularly for renters with limited or fixed incomes.

When speaking about rent and housing prices, it would be careless not to mention the broader cost-of-living challenge. Because our friends and neighbors are stretching dollars farther than ever, the General Assembly must have a real conversation about repealing the state sales tax on groceries and other necessities such as women's hygiene products.

Regarding growth as it relates to schools and roads – I will address those elsewhere.

4. What do you see as the top opportunities for Maury County and how do you plan to utilize those to move our community forward?

First, we have had tremendous investment in local businesses, which has created jobs in Maury County. And that is an incredible opportunity for our county, particularly if jobs pay well. We should be proud of our neighbors who now have a generous UAW contract, but only because Ultium moved to town before the state's ban took effect on "card check" for companies taking state economic incentives. I will push to end state government meddling in labor organizing.

Secondly, we have fantastic health care at Maury Regional Medical Center. We can help Maury Regional care for us by expanding TennCare (our state Medicaid program). Tennessee has, over the last decade, passed up billions of dollars of federal aid that would provide health insurance coverage to hundreds of thousands of Tennesseans, which will help both patients and providers. Expanding TennCare will also help stabilize rural health care.

5. How do you plan to work collaboratively within the Tennessee General Assembly to ensure the decisions being made are in the best interest of Maury County as a whole?

Breaking the Republican supermajority in the General Assembly will ensure better decision-making for Tennessee because one party (the GOP) currently has a stranglehold on the legislative process. If Democrats and Republicans both have the power to bring bills out of subcommittees and to hold meaningful debates about those issues on the floor, then we will have better and more reasonable laws in this state that truly respect the interests of everyone.

About what I intend to do: I can certainly find common ground with local Republican state representatives. I have had several pleasant conversations with Scott Cepicky, and I appreciate the

work he has done on the Duck River issue. I agree with Todd Warner on school vouchers. I think Kip Capley has some interesting ideas regarding tax relief for senior citizens.

6. With the growth facing Maury County, we are in great need of additional, and diversified, revenue streams to help fund the infrastructure to support the inevitable growth. Last session, legislation was passed to allow high growth County Governments to implement certain fees to assist with infrastructure related to growth. Do you feel this is an adequate solution? Why or why not?

I do have to recognize the work that our current state legislative delegation put into reforming the County Powers Relief Act (CPRA), the state law that governs impact fees and the adequate facilities privilege tax.

However, the Maury County Commission repeatedly asked our state legislative delegation for the power to levy impact fees on par with cities (and counties that levied impact fees before the CPRA was passed, such as Williamson County). While significant and beneficial, the 2024 amendments to the CPRA did not include what the Maury County Commission specifically asked for. If we take that as the bar for measuring success, the 2024 amendments were not adequate.

Third, I think the real measure of success is whether we have adequate funding that Maury County needs. We have transportation needs in Maury County that justify the State of Tennessee breaking its long-standing taboo of "no state road debt" to ensure that TDOT is not wasting years and decades while our residents sit in traffic jams.

7. What does thoughtful and sustainable growth in Maury County look like to you?

To me, thoughtful and sustainable growth means that every new family and new business moving into Maury County should have the same opportunity, freedom, and dignity that our current residents have – but at a marginally lower per-person environmental impact and cost to our public services.

We need more alternatives to quarter-acre single-family home subdivisions, such as apartment and duplexes. The grass in rural Maury County ought to be eaten by cows and mules, not by developers and lawnmowers.

8. Quality education and a diverse workforce are vital for the successful growth of Maury County and its municipalities. If elected, how would you improve these areas?

We must protect our public schools, not privatize them. I am strongly against universal school vouchers, which will undermine Maury County Public Schools by taking money out of your child's classroom to subsidize private schools. The proposals floated in the General Assembly and by Governor Lee are like those tried in several other states, blowing up budgets while mostly benefitting wealthier families already sending their children to private schools. If voucher proponents care about "kids trapped in failing schools," then we need to improve our public schools rather than abandon them!

We should continue to improve teacher pay and benefits. The House voucher bill contained

several worthy ideas that would have helped teachers—these should be considered in a standalone bill rather than as part of a cursed bargain. Pay and benefits are important for recruiting and retaining the best teachers. We must also let teachers teach, stop grinding culture war axes, and exercise caution about over-emphasizing standardized tests.

The General Assembly must ensure adequate local and state funding and should also continue acceptance of federal grants. These grants help us fund educate of children with special-needs, career and technical education (CTE), and school lunch programs.

We must remember that not all students are headed to flagship universities. That is why we must equitably fund Tennessee State University, community colleges, and TCAT schools. We should also support and expand CTE programs so that we can help train more career-ready graduates.

With regard to diversity, I think it is important that the General Assembly focus on issues we all care about (such as education and growth) and stop stoking culture war nonsense. I'd be happy to speak to folks personally if they need to have this point clarified, but suffice it to say we are losing out on some very talented people because of misguided legislation.

9. How do you plan to communicate with, and be available to, your constituents?

As a candidate, I have worked hard to build relationships and make myself present in all five counties in the 28th District. I believe one-on-one communication is important, and I look forward to making time for constituents to discuss their issues in person, on the phone, or by e-mail. I also believe it's important to hold community town hall meetings several times a year. Broader approaches such as social media, newspaper columns, and newsletters are also important, but having personal contact is key to building trust.

10. What does a successful term look like to you?

I will consider my term in office a success if, in four years, we have a state that is not only more prosperous but also fairer and more welcoming. I will consider my term a success if more people have health insurance and fewer children die from gunshot wounds.

11. If elected, how do you plan to partner with the Maury County Chamber & Economic Alliance to make Maury County the best place to live and work?

In any community, the Chamber of Commerce is an important source of forward-looking ideas. Businesspeople are often some of the most progressive, pragmatic, and serious thinkers in their communities. I look forward to meeting regularly with Maury Alliance members and learning about your visions for bettering yourselves, your families, and your employees.

TN REPRESENTATIVE - DISTRICT 64 SCOTT CEPICKY



1. Why are you running for this position?

I will continue serving the people of Maury County representing our Conservative values.

2. What specific experience and qualifications do you have that make you the ideal candidate for this position?

TN REPRESENTATIVE - DISTRICT 64 **EILEEN LONGSTREET**



1. Why are you running for this position?

To help the people Maury County in identifiable ways:

- A. To get more money for Maury County schools with an emphasis on Title 1 schools. To work hard to design after-school tutoring programs for 1st and 2nd grade students at risk of not being able to read by 3rd grade
- B. To work on getting guns laws improved to protect our children, teachers and other innocents from AR-15s and any emerging military-style guns to be sold on the open market.
- C. To get legislation passed to limit fees charged to the uninsured by hospitals, doctors, labs and related medical supply organizations to the average fee "allowable" for payment by an insurance company and/or Medicare.
- D. To get Medicaid expanded to encompass all working people with salaries that are not sufficient to purchase insurance in the marketplace and are not eligible under current Medicaid rules unless they are unemployed or effectively living in poverty
- E. To get grant money from the State of Tn to develop temporary and reimbursable assistance to Veterans who are unable to obtain needed equipment in a timely manner
- F. To push for all human beings regardless of race, gender identification, lack of confirmed gender identification, homosexual, or fluid gender to be accepted equally as part of the human race.

2. What specific experience and qualifications do you have that make you the ideal candidate for this position?

35 years in the health care and health insurance industries including senior management roles and consultancy roles; expert testimony to US Senate healthcare Committee, 1999; Board membership in a publicly traded health care company (WellCare); 3.5 years executive leadership of a non-profit serving seniors; 11 years as volunteer-reading tutor of 1st and 2nd graders; Meals on Wheels delivery for 7 years; Treasurer of my Homeowners association; and pleasure in helping others

3. What do you see as the top challenges for Maury County and how do you plan to contribute to addressing those?

- A. Addressing School infrastructure, including more schools for Maury County by redirecting State money from business tax breaks to children's education
- B. Establishing community programs to support tutoring of first and second graders reading ability to create reading fluency by third grade.
- C. Properly assessing the value of Charter Schools and other private schools funded by the State of Tn in terms of purely academic achievement of children and outcomes of certain methods of teaching rather than using meaningless statistics.
- D. Taking the politics out of decisions to fund charter schools and vouchers. Hiring qualified consultants to lead the evaluation of the total of the Tn elementary school system; addressing the

evaluation of secondary schools at a later time. Elementary schools should be the start of the process of fixing the schools. Keeping AS MUCH OF THOSE TAXES IN OUR COMMUNITY (or getting them back from the State) IS PARAMOUNT FOR SUCCESS. Without an educated population nothing can succeed and poverty persists.

4. What do you see as the top opportunities for Maury County and how do you plan to utilize those to move our community forward?

5. How do you plan to work collaboratively within the Tennessee General Assembly to ensure the decisions being made are in the best interest of Maury County as a whole?

I have the ability to talk with people whose ideas are different from mine. I have the ability to listen closely to theirs; I have the ability to foster others' listening to my ideas. Respect is paramount. This is what softens resistance over time. It doesn't guarantee results but it can ultimately engender the respect that can LEAD to compromise.

Last session, legislation was passed to allow high growth County Governments to implement certain fees to assist with infrastructure related to growth. Do you feel this is an adequate solution? Why or why not?

I have not studied the subject yet to be able to answer this question. Taxes are low here however tax increases are never popular. The Sales Tax in the State of Tn is regressive. It hits the poor the hardest. It is time to be able to offer reasonable tax breaks to small businesses and less generous ones to large businesses. It is time to focus on businesses who will hire the people with the kind of skills Maury county citizens have now, even if those skills are not adequate for some types of larger businesses. How to generate infrastructure revenues should largely be the responsibility of City and County planning and implementation. Municipal agencies have been too late to increase utility fees thus creating dissatisfaction. Fees should increase with 'cost of living' increases.

7. What does thoughtful and sustainable growth in Maury County look like to you?

A. Good solid planning and time-sensitive implementation and periodic adjustments as the environment changes.

This is good business practice. Government should be run like a business that serves the people fairly, adequately, in a timely manner, with minimum bureaucracy. Adequate roads, improved safety measures for the increasing traffic, maximizing traffic tickets and violations by drivers and truck drivers to increase county revenues.

B. Implementing auto inspection again to get unregistered, expired registration, dangerously impaired automobiles, and poor attention to good driving practices remedied and to produce additional income. Being a friendly town doesn't mean ignoring revenue opportunities. Communities thrive on order.

C. Ending the prolific licensing of new housing construction prior to having adequate roads and

bridges

- D. Improving schools to attract and retain population growth, and do so with much better teacher pay.
- 8. Quality education and a diverse workforce are vital for the successful growth of Maury County and its municipalities. If elected, how would you improve these areas?
 - A. The City and County are responsible for providing adequate funds, in addition to the state funds, for education. They should actually PROVIDE the needed funding, as should the State.

10. What does a successful term look like to you?



Columbia is becoming a destination city. We want to continue to promote our community as a great place to visit but also ensure that it remains a great place to live.

I recently voted to waive \$325,000 in city building fees for the new Maury County Justice Center and County Archives. The city recently approved the construction of a new \$97 million wastewater treatment plant to replace our 40-year-old plant and also accommodate growth. We also recently applied for a Tennessee Department of Transportation grant to expand the lanes on Bear Creek Pike and pledged \$10 million to cost share this much needed transportation project. We have also earmarked approximately \$9 million in state and federal funds to redesign and build a new intersection at US 412 (Nashville Highway/Bear Creek Pike intersection) to better accommodate traffic. Finally, CPWS is in the final stage of beginning the renovation and expansion of our water treatment plant on Nashville Highway to accommodate future growth as well.

7. What does thoughtful and sustainable growth in Columbia look like to you?

Smart growth to me is the type of growth that does not take away from Columbia's charm and hometown hospitality. We have a wonderful, historic downtown that we want to protect for future generations. 9. What does a successful term look like to you?



1. Why are you running for this position?

I am running for City Council because I want to serve again for my community. I served as a county commissioner from 2018-2022 and while I learned a lot, there is more to learn and more to do for our community.

2. What specific experience and qualifications do you have that make you the ideal candidate for this position?

I am not sure there is an ideal candidate. We are all human and have different opinions. My whole career has been based on service. As a Nurse Anesthetist, I have served patients in the most critical time, during surgery. I also serve on the Board of the Maury County Historical Society, African American Heritage Society of Maury County and the Crossroads to Home Board. I served on the county commission on multiple committees- Budget Committee, Building Committee, Health & Environment Committee, Safety Committee, and Audit Committee. I was also appointed to be on the Public Records Commission and the Library Board. I will use these experiences to work hard for the betterment of Columbia.

3. What do you see as the top challenges for Columbia and how do you plan to contribute to addressing those?

When I go door to door and talk with people in Ward 5, the biggest topic is growth of Columbia and how it has grown too fast. As a county Commissioner, I went to the city planning and council meetings to take a stand against some of the growth plans. I won some and I lost some. I also have this feeling that Columbia is growing too fast. I would like to see more control on growth. I would like to see more collaboration between the City of Columbia and Maury County. It feels like there is a lack of cooperation between the city and county. I know when I was on the commission, the city and county worked together on some projects. I feel that this process has gone by the way side. Let's face it, what the city does affects the county and vice versa. There is a need to work together! When businesses are looking for places to move to, they look at the dynamics of the whole community; i.e. How do city and county interact, how do other municipalities interact with each other, How the schools interact with the County. All of this comes into play.

4. What do you see as the top opportunities for Columbia and how do you plan to utilize those to move our community forward?

I feel the greatest challenges and the greatest blessings in Maury County are the people of Maury County. Whether they have been here 5 generations or just moved here from California, these citizens bring their knowledge and experience to these challenges. We need to tap into that knowledge and experience base and get these folks engaged in the process to help tackle these issues. I have witnessed this first hand. There are folks on the Cross to Home Coalition. This group

of people are from all over the country and are citizens in Maury County working on the homeless issues of the county. It is an amazing experience to sit and listen the ideas and suggestions. New perspectives can generate new businesses and non-profits that can enhance the community.

5. How do you plan to work collaboratively with each municipality and the county to ensure the decisions being made are in the best interest of Maury County as a whole?

That is the trick, right?! Every decision that leaders make should be backed up by facts and statistics. Our community has the benefit of Maury Alliance and thriving companies that will help us determine what our needs are. Do the projections for growth among school-age children over the next 5-10 years warrant a new school? Two more? How much water is required from the Duck River to service our growth and industry? Is that amount sustainable to the river, and what conservation measures can be put into place to make sure the Duck River remains the most bio-diverse in North America? Bringing all the stakeholders to bear is what local government should be all about.

6. Columbia is located in one of the fastest growing areas in the state and country. This tremendous growth will require new and improved infrastructure (i.e., schools, roads, water, etc.). How do you plan to provide these infrastructure improvements, including any required funding?

As a county commissioner, the Commission tried to get legislation passed for an impact fee. These monies would be used for capital projects for the schools. This would have freed up money for roads, water, and other infrastructure needs. Unfortunately, the state legislature was not for this. The city has sewer impact fees which are dedicated to the new waste water treatment. There are also water impact fees. There are no impact fees for the general fund for the city. The city gets funded through sales tax, property tax, gas tax, grants, etc. So, when infrastructure has improved, revenue has to be generated, and unfortunately.... We as a city need to need to think outside of the box. After talking with CPWS, I think they are doing that with the new waste water treatment plant and the possible new water intake on the Duck River. I want to applaud Spring Hill for their pilot study to maximize their share of water, reusing waste water. They are the only city in the state of Tennessee trying this and I think it is a great idea. We have a lot of industry in Maury County, and I know of one company that 80% of their water usage is not returned as waste water. The industrial sector, which uses large amounts of water, should have a higher stake in the water sustainability and conservation issue.

As far as schools go, the county takes care of the schools. However, the city and the Maury County Public Schools (MCPS) need to communicate. I have talked with the MCPS and they are reporting the safety concerns to the city planner and how that relates to the school system. They also report the capacity rates to the city planners to remind them of the capacity of the school that will be affected by a development. I hope this communication continues.

Roads are funded through gas tax dollars and are matched by general fund dollars to the tune of about \$3 million dollars. I would want to see that increased somewhat.

7. What does thoughtful and sustainable growth in Columbia look like to you?

Sustainable growth should be just that...a level of growth that contributes in a positive manner to residential, commercial, and industrial growth. If any of those become a strain on the taxable

incomes of the people, that's a problem. If any of those deplete the environment, that's a problem. When education suffers, or if we see a rise in homelessness, those can be byproducts of unsustainable growth. As community leaders, it is our job to maintain positive levels of growth, and not be afraid to slow or increase growth as needed to ensure a favorable lifestyle for citizens.

8. How do you plan to communicate with, and be available to, your constituents?

My phone number and my e-mail will be available. While I was on the county commission, I consistently put on social media the agendas of all committee and commission meetings and answered question about certain items on the agenda. That seemed to work well, and I will continue to do that as a city council member. I also want to hear from the constituents from my ward.

9. What does a successful term look like to you?

A successful term for me would be to make Columbia better than I found it. I want to build a bridge between the city and the county to make this community better. I want to the city to pump the breaks a little bit on growth. I want to see more commercial projects to help with job growth. I want to work with all the entities of the city to make our city safer for everyone.

10. If elected, how do you plan to partner with the Maury County Chamber & Economic Alliance to make Maury County the best place to live and work?

I know it seems I go back to when I was on the Commission, however, this experience has helped me so much in my understanding of how our local government works. The Maury Alliance always gave the commissioners reports on unemployment rates in the county, job growth rates, how many folks worked in health care, manufactory, etc. They also told us what was in the pipeline as far as industry goes. This was valuable information to use for planning for infrastructure, schools, etc. I value and will continue to use this information to make educated decisions that will affect Columbia.

Now they will pay per single family home to do so. We also have several industrial sites that will come off of their tax abatement and the city will have that money in the general fund (for roads, etc.) going forward.

7. What does thoughtful and sustainable growth in Mt. Pleasant look like to you?

We want to continue to diversify the "mix" of industry and make sure we have a variety of

manufacturing and not just automotive suppliers. On the residential development; the areas being developed are along a main road artery (Hwy 43) where there should not be a major impact on regular in town traffic. Also, the utility infrastructure must be available with off site improvements being the responsibility/cost of the developer.

8. How do you plan to communicate with, and be available to, your constituents?

Communication is an issue. Not many are reading a local paper anymore and some do not access social media. The city has a great texting program, posts meetings on line and the commission meeting each month is live. We always need to find ways to communicate better.

9. What does a successful term look like to you?

Improving our roads is a priority (to also include the infrastructure beneath the road). Having jobs with competitive pay is also a priority. That would make for a successful term!

10. If elected, how do you plan to partner with the Maury County Chamber & Economic Alliance to make Maury County the best place to live and work?

As stated in #8 it is very important to keep communication open with Maury County, the Alliance and other municipalities. We need to all work together and have a regional approach to resolve issues such as water and growth.

1. Why are you running for this position?

I am running for City Commission because I feel I would be an asset to the city of Mt. Pleasant. I enjoy helping people that need someone they can rely on to help them.

Additionally, ensure fiscal integrity by making informed decisions to address aging infrastructure, including water distribution lines, streets, sidewalks, and recreational facilities for the entire community.

4. What do you see as the top opportunities for Mt. Pleasant and how do you plan to utilize those to move our community forward?

Our top challenges can translate into significant opportunities. With numerous requests for residential water taps in Mount Pleasant, the potential for growth is substantial. This growth will generate additional revenue, enabling us to fix, repair, and replace aging infrastructure. Furthermore, increased property taxes, local sales taxes, and state-shared revenue will support the city's long-term plans for maintaining streets, sidewalks, and parks.

5. How do you plan to work collaboratively with each municipality and the county to ensure the decisions being made are in the best interest of Maury County as a whole?

Mount Pleasant now has a significant seat at the table, a position we haven't always enjoyed. Here are some of our notable accomplishments:

- More recent: 2 projects Landmark expansion 85 million /Project Exentria / Project X-Men: In collaboration with Maury County and the Maury Alliance, we've secured a \$45 million investment, creating 85 new jobs with an average salary of \$59,000 per year. Additionally, during my tenure: Smalticeram, Fuel Total Systems, Doug Jeffords, Brazilian Professionals totaling more than \$120,000,000 investments.
- Maury Regional Airport: We continue to strengthen our partnership with Columbia, Maury

County, and Spring Hill to support and enhance the airport's operations.

6. Mt. Pleasant is located in one of the fastest growing areas in the state and country. This tremendous growth will require new and improved infrastructure (i.e., schools, roads, water, etc.). How do you plan to provide these infrastructure improvements, including any required funding?

Addressing Key Issues with Strategic Actions Great question! Here's what we've already implemented:

- Utility Access Fees: We've established utility access fees of \$3,500 each for water and sewer. This approach funds capital projects without burdening existing utility ratepayers.
- Roads: The additional revenue generated will enable us to pave and repair existing streets, improving overall infrastructure.
- Schools: We must first communicate expected housing developments with the school board. Additionally, we need to find creative solutions to ensure the school board has the necessary funding capabilities.

7. What does thoughtful and sustainable growth in Mt. Pleasant look like to you?

First, what does affordable housing look like in 2024? It could mean areas of high-density housing or thoughtful growth with larger lot sizes and more green spaces in various parts of our city. These concepts can be achieved with the right framework, such as a comprehensive transportation plan, up-to-date zoning regulations, and incorporating technology to design sustainable growth.

8. How do you plan to communicate with, and be available to, your constituents?

Utilize technology and assessable communication channels, encourage feedback, create inperson opportunities.

9. What does a successful term look like to you?

Recruiting and Retaining Employees

The old model of offering minimum pay and hoping employees stay is costly in the long run. Instead, we need to find creative ways to provide benefits that enhance employees' quality of life. The reality is that traditional pension plans and post-retirement health insurance are largely a thing of the past. Elected officials must support city leadership and empower them to prioritize employee retention.

10. If elected, how do you plan to partner with the Maury County Chamber & Economic Alliance to make Maury County the best place to live and work?

I currently serve on the Board of Directors for the Maury Alliance and the Maury Alliance Economic Committee. Additionally, I am the Vice Chair of the Maury County Industrial Development Board (IDB) for Cherry Glenn and a member of the Education Board for the Maury Alliance. I also collaborate with Maury County Parks to enhance the quality of life for both community residents and visitors by improving city and county parks.
